Predvideni študijski rezultati:

Metode poučevanja in učenja:

Predavanja: pri predavanjih študent spozna teoretične vsebine predmeta. Del predavanj se izvaja na klasični način v predavalnici, del pa v obliki e-predavanj (v ta namen didaktično pripravljenih e-gradiv v virtualnem elektronskem učnem okolju).

Vaje: pri vajah študent utrdi teoretično znanje in spozna aplikativne možnosti. Del vaj se izvaja na klasični način v predavalnici, del v obliki e-predavanj (v ta namen didaktično pripravljenih e-gradiv v virtualnem elektronskem učnem okolju), del pa na terenu (obisk inštitucij).

Learning and teaching methods:

Lectures: Students understand the theoretical frameworks of the course. Part of the lecture course is held in standard classroom while the rest is in the form of e-learning (with the help of specially designed e-material in a virtual electronic learning environment).

Tutorials: Students enhance their theoretical knowledge and are able to apply it. Part of the tutorial is held in standard classroom while the rest is in the form of e-learning (with the help of specially designed e-material in a virtual electronic learning environment), and part of it on the field (institutions visits).
